I. PURPOSE

The purpose of this Action Transmittal is to notify all DCFS and POS Purchase of Service Permanency and Adoption Staff and Supervisors of actions being taken within the Youth Cash Assistance Programs for the duration of the COVID-19 public health crisis. The changes below address the need to ensure timely and appropriate supports for youth transitioning from care during this crisis.

II. PRIMARY USERS

DCFS and POS Permanency and Adoption Staff and Supervisors.

III. INSTRUCTIONS

A. Youth Cash Assistance

The current practice which limits annual cash assistance to \$2000 for the Youth Cash Assistance Program (YCAP) pursuant to **PROCEDURES 302 APPENDIX M-TRANSITION PLANNING FOR ADOLESCENTS**, including the YHAP Transition and YCAP Crisis Programs, will be waived. The waiver is valid for those cases terminated in tandem to the onset of the Governor's Gubernatorial Disaster Proclamation, Executive Order 2020.22 due to the COVID-19 Pandemic, and for those scheduled to terminate during the Disaster Proclamation. Program participants may receive services under this waiver for 30 days following the termination of the disaster declaration.



To ensure there are no increased risk of COVID-19 exposures and to maintain a safe and stable living arrangement, per the Governor's Executive Order 2020.22 issued on April 7, 2020, youth who will turn 21 may elect to stay in their DCFS paid placement [Independent Living (ILO), Transitional Living Program (TLP), Foster Home Specialized (FHS), Therapeutic Foster Home (TFH), Foster Home Boarding DCFS (FHB), Foster Home Private Agency (FHP), Institution Private

Agency (IPA), Group Home (GRH), Home of Relative (HMR), Home of Fictive Kin (HFK)]. This option is being offered to all youth turning 21 during the months of April, May, and June of 2020.

If a youth elects to shelter in place and remain in a placement, the POS Agency must send the following information to both the DCFS.CPUDCFSMailbox@illinois.gov and the assigned DCFS-POS Monitor:

- Youth Name
- DCFS ID
- Date of Birth (must turn 21 in April, May, June)
- Placement Type
- Provider Name
- Provider ID

For youth electing to remain in DCFS-managed placements, the DCFS caseworker must send the identifying information to DCFS.CPUDCFSMailbox@illinois.gov and notification to the DCFS Regional Administrator.

For those cases closed October 1, 2019 through March 31, 2020, those youth may request assistance from the Youth Housing Assistance Program and the Youth Cash Assistance Program. Youth receiving Cash Assistance must meet all four of the following criteria:

- Be at least 18 and less than 21 years of age OR over 21 and have aged out between October 1, 2019 and March 31, 2020; and
- Are currently under the care and custody of DCFS and ready for case closure OR have aged out of DCFS care between October 1, 2019 and March 31, 2020. (Note: Youth who moved to adoption or subsidized guardianship are NOT eligible for cash assistance); and
- Have completed a budget statement (Form CFS 370-5C) that demonstrates that with any subsidy and all other income they will likely be able to cover all remaining living expenses (e.g. housing, utilities, clothing, food); and
- Need cash assistance in order to attain or maintain stable housing.

B. Youth Housing Assistance:

Current or former youth in care of the Department may receive, cash assistance to help attain or maintain housing stability.

Cash assistance will vary depending on individual situations and may be authorized for any of the following reasons:

- Housing security deposit;
- Rent (limited circumstances);
- Beds for youth and their children;
- Current utility bills or utility deposits;
- Appliances;
- Partial housing subsidy for a period of one year following case closure; or

Note: The youth's DCFS case must be closed before they can obtain the partial housing subsidy. (Housing costs must exceed 30 percent of income and assistance cannot continue past their 21st birthday)

• Other items required to avoid or manage a crisis.

C. Family Advocacy Centers (FAC's)

FAC's are available to assist youth with the following:

- Help youth get a copy of important documents, including birth certificate, Social Security card and medical records;
- Help youth get a state identification card or a driver's license;
- Help with transportation when youth start a job or training program;
- Help youth connect to community-based adult services to receive needed support; and
- Help with housing referrals and application.
