#### **Family Advocacy Centers**

Family Advocacy Centers (FACs) are community providers around the state that provide an array of core services as well as tailor their services to the individual needs of the communities they serve. FACs are generally not part of the child welfare system and can serve both general community clients as well as those who are, or have been, involved with DCFS. Anyone can be referred to FAC services, and anyone can walk in to a FAC to request services, including families reported to the hotline who need supportive and preventative services instead of an investigation.

FAC mission: promote permanency by maintaining, strengthening and safeguarding the functioning of families, in order to:

- · Prevent substitute care placement.
- · Promote family reunification.
- Stabilize foster care placements.
- Facilitate youth development.
- Ensure the safety, permanency, and well-being of children.

#### **FAC core services**

- Advocacy
- Mentoring
- Parent support and training
- General counseling
- Employment readiness training
- · Family and youth development support
- Financial literacy training for youth 18-21
- DCFS alumni services (legal docs, transportation, financial support)
- English/ESL classes
- Parenting classes



- Help families successfully exit the child welfare system.
- Offer a wide variety of services and supports to families.
- Connect families to community-based supports.



#### **Family First updates:**

- Since replacing the CFS 507 form on July 1, there was a **50% increase in referrals** submitted through the Provider Module from Q1 to Q2.
- 100% of FY25 contracts in payable status.
- 1,630 referrals made to date for all Family First interventions.
- Providers report **64.8% of parents are mostly or very engaged in services.**
