DECISION

The licensing worker must attach a statement that the following criteria have been met:

- ▶ a licensed child welfare agency or the Department proposes to place an additional child or children in the home for the purpose of meeting the best interest of youth in care;
- ▶ a licensed child welfare agency or the Department has documented in the child's case record that this home is the most appropriate choice for placement and is consistent with the best interests and special needs of the child or children; and
- ▶ the foster family is otherwise in compliance with the licensing requirements of this Part and can meet licensing standards for the additional child or children.

If the request for an Expanded Capacity Foster Home License also requires that the age requirements in Rule 402.15 (b)(1)(2) be waived in order to place a child in a foster family home , the attached statement must also document that there are a sufficient number of suitable adult caregivers to ensure that the children receive proper care and supervision.
